# Fire Chief Report -

## **Operations:**

- Good response during snowstorm calls (5/18)
- Preparing review of LFRA/Estes auto aid in Highway 34 canyon as it reopens
- Completing firefighter evaluations that should have been done in January. Have schedule.
- Set up in EverBridge for mass notifications

## Administrative:

Changes in Bill Pay system (Erika to discuss)

- Changing uniform company after poor follow through of previous company

## Membership:

- Have assigned mentors to all new applicants.
- Goal to improve their experience through application process and address questions early
- Same mentor will help coach them one-on-one through new member task book

## Prevention:

- Town passed code amendments for vacation homes.
  - F1 and F4 attended Town Board meeting to discuss, but conversation cut short
  - Did maintain sprinkler standards originally reviewed
  - Maintained egress windows.
