Moved by Mike Kearney, seconded by Ed Ford to accept paid bills. Motion carried unanimously.

OLD BUSINESS

NEW BUSINESS

Resolution 2018-05 a resolution of support for Estes Valley Fire Protection District Ballot Issue 6A to Adjust Mill Levy Rate was presented to the board. Motion by Mike Kearney, seconded by Dave Coleson to approve resolution 2018-05 a resolution of support of ballot issue 6A. Motion carried unanimously.

Chief Wolf presented resolution 18-06 a resolution to amend the 2017 budget. This resolution is to amend the general fund budget for 2017 due to a capital purchase made in December of 2017. Motion by Ed Ford, seconded by Mike Richardson to approve resolution 18-06 to amend the 2017 budget. Motion carried unanimously.

2017 audit prepared by Steve Dazzio came back clean and with no issues.

Chief Wolf presented his assumptions he used to prepare the 2019 budget that will be presented to the board on 10/10/18.

Revenue Assumptions:

- Sales Tax growth of 3% over previous year (+\$25,000)
- Property tax revenue stable, consistent with early valuation estimates from County (+\$2,300)
- Full year of Plan Review & Permit Fees (+\$50,000)
- Full year of Impact Fees (+38,000)
- No revenue expectations for Squad 3 and Ladder 6 sale, but rough estimate is \$100,000 combined

Expense Assumptions:

- General contract costs increasing by 5%
- Inflation of 3%
- Withdrawal from Capital Reserve for new Ladder Truck (-\$200,000)

Reserve Notes:

- Capital Reserve of \$477,000 (end 2018)
- Operating Reserve of \$600,000 (current)
- Target of Operating Reserve was 50% of operating expenses
- Recommended savings by Accounting and Legal is 25% of operating expenses
- Have received feedback that reserves >25% will disqualify for many grants
- Potential grant amounts could be as high as \$200,000 per year if need demonstrated
- Does this change our reserve strategy?

The board discussed future meeting dates to comply with posting requirements for the budget process. 10/10/18 the budget will be presented to the board. 1st publication notice will be for the 11/14/18 meeting and 2nd notice will be for the 11/28/18 meeting. Adoption of the budget will take place on 12/12/18.

Chief Wolf presented a proposed change to the leave and floating holiday policy. The proposed change would better align with our current payroll and accounting program. Chief Wolf has talked to all the current staff and no issues were voiced. The proposed change would remove floating holidays (24 hours a year) and roll those into the allotted vacation time. Leave (both vacation and sick) would then be accrued per pay period instead of monthly. This will go before the board for a vote on 10/10/18.

The next regularly scheduled board meeting will be October 10, 2018 at 6:00 p.m. at Dannels Fire Station.
