The FPPA committee presented to the board their findings on potentially affiliating with FPPA for the volunteer pension fund. Both Brian Tseng and Captain Spear went through a slide deck they put together outlining fees, returns on investments, pros and cons of affiliating, and Q&A. The committee recommended to the pension board to continue to pursue the possible affiliation by writing a letter that would be disseminated to the membership and current pensioners of a future meeting to get their feedback and give them the ability to ask questions. There was consensus to keep moving forward. Captain Spear to generate the letter to be sent to the membership and pensioners.

Consideration of R. Goodrum Pension Eligibility for Year 2022

Captain Rick Spear presented to the board the letter that R. Goodrum provided to him asking to be granted pension credit for year 2022 due to his response and performance. Background was given that the first year of service has not counted in the past as it was considered a probationary year. Discussion was had on if the metrics used were an appropriate standard or if they need to be changed. Consensus was that the active membership policy #301 and the pension policy #185 should be reviewed and updated.

Discussion was had about how many members this situation affects, and it was determined that it affects all members. It was discussed that if this was granted to R. Goodrum that it would open this up to all members and past members and could have a detrimental impact on the pension fund and actuarial.

Motion by Ryan Bross, seconded by Captain Rick Spear to deny the request by R. Goodrum. Motion carried unanimously.
