Ryan Mitchell went over a proposed change to asset allocations with the board that may yield higher returns while keeping risk low. The current distribution of assets are: 34% stocks, 6% real estate & commodities, and 60% bonds. Ryan proposed a change to 35% stocks, 50% bonds, and 15% alternatives or 30% stocks, 55% bonds, and 15% alternatives. Options given in the alternatives category may include alternative lending, corporate lending, reinsurance funds or value/momentum premiums. The board discussed this and asked questions. No change was made at this meeting.

Approve Application Form for Pension Disability

The board reviewed the application form for pension disability as returned from legal review. Discussion took place. A question was asked about the lack of a notary space on the application when the bylaws state that it needs to be notarized.
