NEW BUSINESS

Presentation of 2019 Budget

Chief Wolf presented the proposed 2019 budget by division to the Board.

Revenue Assumptions:

- Sales Tax growth of 3% over previous year (+\$25,000)
- Property tax revenue stable, consistent with early valuation estimates from County (+\$2,300)
- Full year of Plan Review & Permit Fees (+\$50,000)
- Full year of Impact Fees (+38,000)
- No revenue expectations for Squad 3 and Ladder 6 sale, but rough estimate is \$100,000 combined

Expense Assumptions:

- General contract costs increasing by 5%
- Inflation of 3%
- Withdrawal from Capital Reserve for new Ladder Truck (-\$200,000)

Discussion took place on what adding a fuels crew would look like.

Chief Wolf brought the proposed change to the leave policy to the board for the 2nd time. Moved by Ed Ford, seconded by Mike Kearney to approve the change to the leave policy as stated. Motion carried unanimously.

Moved by Doug Klink to enter executive session pursuant to Section 24-6-402 (4)(f) C.R.S. for purposes of discussing personnel issues regarding salary at 6:29pm.

Entered back into regular session at 7:39 pm.
