OLD BUSINESS

Training Site-

- In removal of existing concrete slab, identified that rebar is below concrete in many places and concrete varies from 5" to 7" (spec was 6" thick)
- Meeting with JB Sittner, Stewart, concrete sub. Proposal to cap with 4" slab with fiber mesh.
- Stewart is running proposal past engineers to see if acceptable. If not, will remove entire slab and replace
- Received bid for building Fire Facilities. Working to get price within budget.
- Height variance application has been submitted and processing. Expected decision in March.

Water Supply to the Station-

NEW BUSINESS

2016 Year End Reports were presented by Chief Wolf, Training Captain Marston, Fire Marshal Robinson, and Fire Inspector Franklin. Each provided handouts highlighting events and statistics from 2016. These handouts are on file for review at the Districts office located at 901 N Saint Vrain Ave, Estes Park, CO.

Highlights included but are not limited to:

Responded to a record number of calls in 2016 -685. Membership is at 43 active volunteer members. Hired a full time Fire inspector. Three longstanding members retired. Purchased a type 1 pumper to be delivered summer of 2017. Purchased a new command vehicle. Upgrades to the training site have started with the anticipation of constructing a burn building on the site in 2017 to host fire academies & other training. Members participated in a total of 3,204 training hours in 2016. The 2017 training calendar was presented to the board. Target Solutions was implemented to help push training out to members, track JPR's, and allow home based training. 259 plan reviews were completed by Fire Marshal Robinson showing an increase in new construction. Fire Inspector Franklin completed 541 Fire Hazard surveys. Both Robinson and Franklin participated in and conducted many public outreach activities and WUI inspections focusing on safety and prevention.

The board discussed the Chief review process. It was concluded that this topic would be tabled and discussed at the 2/8/17 board meeting when more members would be present.

The next board meeting is scheduled for February 8, 2017 at 6:00p.m. at Dannels Fire Station. Meeting adjourned at 7:34 p.m.
