Fire Chief Report -

- Lieutenant Grasso has elected to retire after 17 years. We will be celebrating his service at the Thanksgiving Pot Luck on November 22.
- Accepting applications for the open Lieutenant spot (F11). Not planning to fill the "elected" Lieutenant spot at this time (F15).
- Have received all insurance quotes and reviewing end of this week.
- Continuing IT services with Connecting Point at 20% discount from 2016 pricing. This is month-to-month, so able to continue to evaluate. Beginning server replacement scheduled for January 2017, which will be on 48 month lease (spread out cost and enable for easier upgrades/replacement as necessary).
