Secretary Hamrick quoted items from the 2022 US Fire Administration Summit on Fire Prevention & Control. These items underscores the need for us to highlight the work we are tasked with.

During a fire today, you have the least amount of time to exit than at any other time in history Your chance of dying in a fire today are higher than 40 years ago

Fires disproportionately affect lower income communities

1/3 of the US population live in the WUI

Fire departments (both career and volunteer) are experiencing personnel shortages
Technology including mobility products powered by lithium batteries are providing a new ware of

fire causes

Automatic fire suppression systems like sprinklers save lives, yet resistance remains

## **NEW BUSINESS**

# Election - Discussion & Sharpen the Pencil

The district is holding two open houses for community input this month, one next week on the 18<sup>th</sup> and one on the 30<sup>th</sup>. A ballot question will need to be certified by the end of February. The district has conducted an internal survey, a community survey, and Bill Ray from WR Communications has compiled the results and presented it to the board at previous meetings in 2022. Given the information gathered, where do we go from here? At this time we do not feel like we have community support to make an ask for a bond successful. There is still a need for facilities, but we need more time to educate the community.

Discussion took place and questions were asked about the various elements of the strategic plan and how to prioritize them. If we hire more people, we need a place to put them. Do we rent space or purchase an existing building. Pros and cons were discussed. The district is still in talks with the Town of Estes Park about possible 1A tax if it was renewed in a 2024 election. Discussion took place on other funding options such as grants or starting a foundation. Pros and cons were discussed.

Floor was opened for public comment. Comment was received from three people. Comments included: The bond can't be pushed off forever, the need is still there. Can the district afford to renovate station 71 if there is no bond? Needs need to be confidently communicated.

Brian Tseng noted that the board needs to be accountable to the mission.

Purchase of property has been tabled for later discussion.

Consensus was made to drop the ask for a bond, but to not change the mill levy ask at this time. The district is going to continue to push social engagement and the board members will continue to submit letters to the newspapers.
