President Doug Klink called the meeting to order at 6:01 p.m.

Chief Wolf led the Pledge of Allegiance

Secretary Goetz performed roll call - Dave Coleson absent excused

APPROVAL OF AGENDA

Moved by Mike Richardson, seconded by Mike Kearney to approve the agenda with modification to move item 11E to 8-Presentations. Motion carried unanimously.

APPROVAL OF MINUTES

Moved by Ed Ford, seconded by Mike Richardson to approve the 4/18/18 meeting minutes as written. Motion carried unanimously.

Presentations – Item 11E

Chief Wolf presented the options for De-Gallagherizing to the board.

Option 1: No change

Option 2: De-Gallagherize in 2018 at current levels (\$628,000)

Option 3: De-Gallagherize in 2018 at different level (>\$628,000)

Option 4: De-Gallagherize in 2019 at higher than expected level (>\$570,000)

Option 5: Don't De-Gallagherize, but increase mil levy based on anticipated loss (≥2.15)

Discussion followed with points to consider.

Pros to De-Gallagherizing

- Lock in revenues at current levels
- Do not have to go back to the voters for future decreases in RAR
- Ballot question would read "approve setting District revenues at \$628,000, a 0% increase on current tax levels" if asked in 2018. In 2019 would be based on current levels at that time

Cons to De-Gallagherizing

- Unable to capture future growth in property valuation without another vote
- Put increased burden on Commercial (same as increasing mil levy)
- Cons to no action
 - Potential loss of revenue beyond our control
 - Forces eventual mil levy increase to simply maintain revenue levels

Unknowns

- Future growth of sales tax (is this sustainable?)
- Future legislative fix for Gallagher?
- Timelines on both

Discussion Points

- Revenue growth has mostly been driven by Sales Tax, not Property Tax
- How long is Sales Tax growth sustainable?
- What do we think housing prices will do long term?
- What is our confidence State can solve Gallagher?
- How will waiting impact our question?

Chief Wolf was asked to reach out to other special districts and see what they are planning. Due to deadlines for fall TABOR ballot questions, time is of the essence. The Board is concerned that the Gallagher impact will cause voter fatigue if this is drawn out.

Dispatch

Chief Wolf presented a handout for a proposed change of dispatch and it included a matrix to help the decision making process.

"Proposal for Estes Valley Fire should enter contract negotiations with Loveland Dispatch (200) to provide 911 services. I consider this to be the best choice for the District to support our mission and direction as an organization. Culture of Loveland Dispatch is in alignment with our organizational values and priorities. Loveland Dispatch has strong working relationship with Loveland Fire Rescue Authority, who has already built many of the features we seek in dispatching technology, Loveland is currently an ACE Accredited Dispatch Center with a track record of high performance."

<u>Treasurer's Report</u>- President Klink reviewed the April 2018 balance sheet(s) including, but not limited to: governmental funds and schedule of capital assets, statement of revenues, expenditures, and changes in fund balance for general operations, operating reserve, Tabor and capital reserve were also provided.

- Have requested Bank of Colorado to set up new Savings Account specifically for Impact Fee Revenue, request was met with Board approval.

Chief Wolf presented the findings of the Colorado School of Mines GIS project. This year's project focused on mapping out the type and density of vegetation as it relates to homes in the Estes Valley and the map of various water supply sources. These GIS projects are being done by students at the Colorado School of Mines at no charge to us.
