### APPROVAL OF AGENDA

# **NEW BUSINESS**

### Change in Volunteer Representation

Captain Spear updated the board that the terms for the volunteer representatives are two years per the bylaws. Both Captain Spear and William Harkins have served longer than two years. Captain Spear will ask for new representation at the August volunteer membership meeting. His plan is to stagger the terms.

## Actuarial

The actuarial study that Milliman put together was sent out ahead of the board meeting. President Bross noted that everything in the study seemed on par with what he would have expected considering how the market performed last year. It was noted that the fund is 69.4% funded. Captain Spear indicated that he was not going to ask for any change to the current payment rate due to the lower funded percentage liability. William Harkins agreed.

## 2024 Budget

Chief of Staff Goetz noted a couple of changes that should be made to the 2024 pension budget. An increase of the retiree benefit payments from \$155,250 to \$163,485 due to new members entering the plan. Increase the retiree death benefit from \$800 to \$900 to reflect the max monthly payment that was increased several years ago.

### RECORD OF PROCEEDINGS

Chief of Staff Goetz also noted that the district made their \$54,000 contribution to the pension account on 7/21/2023.

Volunteer Pension Fund Bylaws - Section 7 - Disability Benefits for On-duty Injuries

The pension bylaws were sent to the board ahead of the meeting for review. A member has requested the application to apply for pension disability. No form has been located. Section 7.1 of the pension bylaws states that "the board shall prepare and approve forms for use by applicants." A proposed form was presented to the board. Suggested additions include adding a signature and date line along with a section for the form to be notarized. No vote for the approval of the form was called as the board wants the changes made to the form then sent for legal review. It was noted that the board may want to have an executive session at a future meeting with legal as to better understand the process as outlined in section 7 of the bylaws.

Next Pension Board meeting will be TBD in 2023.

Motion by Captain Spear, seconded by Brian Tseng to adjourn the meeting. Motion carried unanimously.
