President Doug Klink called the meeting to order at 6:01 p.m.

#### **PUBLIC COMMENT / BOARD COMMENT**

Frank Theis appeared before the board to voice a couple of concerns with the implementation of impact fees. Mr. Theis feels that there needs to be public outreach of our intent to implement impact fees. The cost to builders keeps increasing and they need to be informed as this impacts their bids for new construction. Mr. Theis also feels that there should be a moratorium on when these fees would start being collected due to open bids and bank financing that may already be in place for new construction. Mr. Theis was also wanting to clarify the distinction between single family and multi family units. President Klink wanted to ask the board if there were any concerns with the department participating in the Big Elk VFD and EVFPD charity auction. The consensus from the board was that we would provide the central location for the auction, but not take any money for it. Instead we would like Big Elk VFD to reach out to Glen Haven for their support and to split the proceeds with them. Both of these neighboring agencies do not receive any tax revenue and would benefit from the money raised. President Klink asked Chief Wolf if we need to look into a policy on excessive calls ie: elevator rescues. Chief Wolf stated that we do have a policy in place.

Mike Richardson made a public apology for being late.

#### **APPROVAL OF AGENDA**

Moved by Dave Coleson, seconded by Mike Richardson to approve the agenda as written. Motion carried unanimously.

### APPROVAL OF MINUTES

Moved by Mike Kearney, seconded by Dave Coleson to approve the 12/13/17 meeting minutes as written. Motion carried unanimously.

**Presentations** – Chief Wolf, Captain Capo, and Office Manager Erika Goetz presented the board with a powerpoint and discussion on the 2017 annual report. Major points of interest were the updated ISO rating, development of a strategic plan, completion of our 1<sup>st</sup> fire academy, streamlining processes with the use of technology and contract negotiations for cost savings. In 2016 we recorded a total of 3,206 training hours and in 2017 we increased to 4,702 training hours (5,107 if you include members of our mutual aid departments). We had a 100% pass rate at our fire academy. Total calls ran in 2017 was 720.

### **NEW BUSINESS**

Moved by Mike Richardson to amend the 2017 adopted budget to reflect the 2017 projected budget numbers as stated in the financial report dated 1-18-18, seconded by Mike Kearney. Motion carried unanimously.

HERO Plus LOSAP program is ready to move forward with the money transfer. President Klink voiced concern that this money would not be available to us if a natural disaster hit and impacted our revenues. Chief Wolf indicated that this money has already been set aside for the volunteers and our capital reserves should be sufficient should we need money. Members of the board stated that this is a good opportunity for the volunteers to have more control over their LOSAP allocations and consensus was to move forward with the change to HERO Plus.

A LOSAP application for C. Rahn was presented to the board. Rahn met the requirements and left in good standing. Moved by Mike Richardson, seconded by Dave Coleson to approve Rahn's application for LOSAP in the amount of \$6,229.13. Motion carried unanimously.

# **RECORD OF PROCEEDINGS**

Resolution to approve impact fees was tabled due to the boards consensus that public outreach needs to be done. Chief Wolf is to issue a press release prior to the board meeting on 2/28. On 2/28 the board will hear public comment on the issue. Chief Wolf also indicated that we should have a policy in place incase someone asks for reduced fees or fee waivers. Target date to start implementing fees has been changed to 7/1/18.

The next regularly scheduled board meeting will be February 28, 2018 at 6:00 p.m. at Dannels Fire Station.
